Rationale:

- Q2FY26: Earnings miss on higher costs, lower volumes.
- Management expects demand in the northern and western regions to be better than the rest of the country in the near term.
- Capacity expansion likely to be linked to demand.
- Margin recovery likely to be back-ended in H2FY26E.
- On a standalone basis, we estimate EBITDA of Rs1,263/1,322/1,376 per ton in FY26/27/28E vs Rs1,106 per ton in Q2FY26.
- We value the company 9x EV/EBITDA December 2027E.
- We remain watchful of its ‘value over volume’ strategy, which may be challenging to sustain, given peers’ planned capacity.

👍 Positives:

- Premium product share improved qoq to 21.1% (17.7% qoq).
- Management aims to maintain the share of premium cement at current levels.
- We expect demand to pick up after the festive season in November 2025.

👎 Negatives:

- Volumes, at 79 lakh tons, (-11.6% qoq) and were below our estimates.
- Blended realizations decreased 1.6% qoq on lower prices in key regions.
- Costs, at Rs4,334/ton, increased 4.3% qoq (+4.4% yoy).
- EBITDA, at Rs1,106/ton, decreased qoq by Rs267/ton.
