Result Update

Current Market Price (CMP) Rs.570	Fair Value (FV) Rs.725

Rationale:

- LICHF’s core growth was marred by continuing intense competition in the mortgage industry, with repo rate cuts driving down yields and competition taking away customers.
- Rapidly falling funding costs provides some comfort.
- Asset quality is holding on well, with potential upsides from recoveries.
- Maintain BUY with Fair value of Rs. 725.

Q2FY26 Earnings Update:

👍 **Positives:**

- LICHF reported Profit After Tax (“PAT”) of Rs. 1,350 Crores in Q2 FY26, up 2% yoy and 2% above our estimates. The core Profit Before tax (“PBT”) was 1% above estimates.
- Cost of borrowing declined 11 bps qoq to 7.4%. The Incremental cost of borrowings was lower than the book cost at 6.7% in Q2 FY26.
- Operating expenses were down 3% yoy.

👎 **Negatives:**

- Net Interest Margin compressed 6 bps qoq to 2.6%, driven by the drag of lending rate.
- Credit cost were elevated at 22 bps (11 bps in Q2 FY25 and 25 bps in Q1 FY26), driven by elevated write-offs.
- Overall Disbursement were down 1% yoy.
- Net interest Income was muted at 4% yoy.
