

State Bank of India (SBIN) - BUY

Q2FY26 Result Update

Current Market Price (CMP) Rs.958	Fair Value (FV) Rs.1100

Rationale:

- SBI reported ~10% yoy earnings growth, led by 10% yoy operating profit growth.
- The bank was able to deliver a marginal Net Interest Margin (NIM) expansion in a challenging quarter.
- Loan growth was healthy at 13% yoy, while slippages were low at 0.5%.
- With a key quarter behind, the near-term outlook on core business performance is likely to show improvement.
- Retain BUY with an FV of Rs1,100 (Rs1,000 earlier). SBI remains a top idea.

👍 Positives:

- Gross NPL and net NPL ratios declined ~10 bps qoq to 1.7% and 0.4%, respectively.
- Gross slippages for the quarter were well-contained at ~Rs5,000 cr (~0.5% of opening gross advances) against ~Rs8400 cr in Q1FY26.
- Overall loan growth stood at 12% yoy and up 4% qoq.
- Domestic advances also grew by 12% yoy and up 3% qoq.
- Domestic NIM also improved 7 bps qoq to ~3.1%.
- Non-interest income growth was strong at 30% yoy, led by higher treasury income.
- Q2FY26 was ahead of our expectations on NIM and asset quality.
- The bank is well-capitalized currently with Common Equity Tier (CET-1) at ~13%.

👎 Negatives:

- Cost-income ratio increased ~150 bps qoq to 49%.
- Growth in corporate loan book was relatively muted.
