Q2FY26 Result Update

Rationale:

- Devyani’s domestic revenue grew 12% yoy.
- EBITDA margin at ~5% was significantly weak due to elevated promotional spending, Sky Gate consolidation (120 bps impact) and weak operating leverage.
- International vertical fared relatively well, with 13.7% growth.
- We expect earnings to grow by 86.8% in FY27E & grow by 331.3% in FY28E.
- No adverse impact from Yum’s potential exit in Pizza Hut (PH).
- We cut our FY2026-28 EBITDA estimates by 4-14% and revise FV to Rs170 (from Rs177) at ~33X Dec 2027E attributable pre-Ind AS EBITDA.
- Stock is currently trading at valuation of 660.9 P/E FY28E EPS.

👍 Positives:

- DIL revenue grew 12.6% yoy to Rs1380 cr (2.3% beat), led by 13.7% store growth.
- Domestic/international topline grew 12%/13.7% yoy.

👎 Negatives:

- Gross Margins (GM) declined 160 bps yoy to 67.8% (domestic/international at 69.7%/63.7%).
- EBITDA declined 29.4% yoy to Rs46.2 cr, impacted by RM inflation, promotional investments, and higher delivery charges.
- Discretionary slowdown continues to weigh on SSSG/operating leverage.
